THE ALLIANCE HAD ABOUT 40 MEMBERS AT END OF THE YEAR. THEY ARE BROKEN DOWN IN FOUR CATEGORIES AND THE MEMBERSHIP DUES LEVEL VARIES ACCORDINGLY: GOLD, SILVER, BRONZE AND EVSE. AFTER JOINING THE ALLIANCE, MEMBERS ARE URGED TO BECOME ACTIVE IN THE TWO MAJOR COMMITTEES, AND PARTICIPATE IN STATE ACTIVITIES IN A COLLABORATIVE WAY TO ADVANCE SUCH PRINCIPLES. DUES ARE ASSESSED AND PAID ANNUALLY.
